WCOC, FOUNDATION, SETTLE LAWSUITS WITH SLANDERED HERO

(MCFP) Millennium City, IL - Attorneys for local television station WCOC and a Texas political think tank have come to a settlement in their respective slander and libel lawsuits initiated by John Battle, the "Legacy Hero" whose name and his family's reputation were maligned in the "Real Truth" website and repeated on WCOC.

"These settlements will bring some measure of closure to the malicious damage done to my client and his family," said attorney Candace Sinclair.

"John Battle and his family are good people, dedicated to fighting for justice and the betterment of all Americans, including Native Americans."

In 2019, an article posted on the "Real Truth" website reportedly by famed reporter Pedro Duarte claimed that Battle was involved in a fraudulent deal that gave tribal lands belonging to the Yavapai Tribe in Arizona to the corporate conglomerate ARGENT.

This was followed by a video reportedly by "Chief Crow" claiming that the land in question was being used for an oil fracking center and was causing ecological and seismic damage to the area.

Both the article and the video were then broadcast on WCOC by local reporter Mercedes Reale. A follow-up interview by WCOC with the person claiming to be Duarte then accused Battle's family of falsely claiming to have Native American heritage.

It was later determined that all three articles were created by the Marsh Foundation, an ultra-religious political think tank.

Under the terms of their respective settlements, both WCOC Studios and the Marsh Foundation will each be making an undisclosed financial donation to the Bloodfeather Foundation, a non-profit organization created and managed by the Battle family to help the Native American tribes and their various social issues.

Ownership of the "Real Truth" website has also been surrendered and transferred to the Bloodfeather Foundation as part of the settlement with the Marsh Foundation.

ALLEGED MURDERER IN COMA AFTER FALL

(MCFP) Burning Sands, NM - Admitted murder and disgraced hero Lucas Thunderwolf is currently in a comatose state following an incident at the Stronghold supermax prison.

Thunderwolf, 23, was held in the Stronghold facility while he awaited trial for the murder of Arizona developer Samuel Arkin following a fraudulent deal that temporarily surrendered land belonging to the Yavapai Tribe to the corporate energy resource company known as ARGENT.

Stronghold officials say that holding accused criminals prior to trial rather than at a local jail is normal when dealing with certain super-powered individuals, who can easily overpower normal detention facilities.

Thunderwolf was held in a wing of the facility that houses only pre-trial individuals and are under power restrictions at all times. Prison officials say that the incident is still being investigated and would not be able to provide any details until their investigation is complete.

IDENTITY OF JOHN DOE VICTIM STILL A MYSTERY

ARGENT CLAIMS “CONFUSION”, PLEDGES NEW CULTURAL CENTER FOR TRIBE

(MCFP) Prescott, Az - For the past few months, the presence of ARGENT construction trucks and a makeshift construction area has served as a conflict of messages for the members of the Yavapai Indian Tribe.

Originally promised as a cultural and community center to highlight the proud tribe, ARGENT agents were seen scouting out natural resources and began sending offers to buy whole neighborhoods far beyond the proposed center.

Then, a story was released on the “Real Truth” website allegedly by famed reporter Pedro Duarte that the agreement for a cultural center became a backdoor agreement for an oil fracking site for the energy conglomerate. An agreement that was allegedly made with the help of the “Legacy Hero” John Battle, formerly a regional hero before moving to Millennium City.

A follow-up video posted on the “Real Truth” website by someone claiming to be “Chief Crow” claimed the oil fracking site was causing widespread devastation for the tribe.

Now ARGENT officials have cleared up the confusion.

“Obviously there was some miscommunication,” said ARGENT regional representative Myron Edo. “Our development team received the wrong information and began work on a refinery construction instead of a community resource project.”

Edo did not comment on the erroneous reports posted on the “Real Truth” website, or on the video from “Chief Crow”, which was later revealed to be a computer-generated forgery. Edo did put the blame for the confusion entirely with a local resident of the tribe, Lucas Thunderwolf.

Thunderwolf, 23, was arrested by local hero Ms. Arizona after a protracted fight with John Battle himself, where he confessed on live television to being behind what Edo called the “miscommunication”. Thunderwolf also confessed on air to the murder of local developer Samuel Arkin, whom Thunderwolf had approached to arrange the development deal and had requested Battle to help sell it to the tribal elders.

“Mister Thunderwolf was an overly-ambitious individual,” said Edo. “ARGENT was unaware of the duplicitous activity. Had we known his planned deception, we would not have consulted him in the first place.”
